## CHALLENGES DURING 2021


Once 2021 got underway, we were facing challenges that needed action. They included:

- 1. The pressure of the pandemic and having to meet virtually.
- 2. Funds for the first phase of the Constitution Corridor Project.
- 3. Frequent traffic delays on Henrico Road due to Norfolk Southern train stoppage at the at-grade crossing. This blockage often resulted in many hours of truck and vehicle delays resulting in loss of revenue for businesses.
- 4. The complexity of the Overlay District standards and regulations which was a detriment to new development and commercial business growth.

In order to meet these challenges head on we took action.

 We improved the overall quality of the board meetings through enhanced technology.

- 2. With the help of Commissioners
  Johnson and Terry, we were able to
  acquire a commitment for \$3.6 million
  to assist with the funds for the design
  and remaining construction cost, for
  the Constitution Corridor Project. This
  was a great victory.
- 3. Working with Norfolk Southern, we were able to identify peak travel times in order to encourage freight movement on tracks at times other than peak hours. This is an ongoing effort.
- 4. With the Overlay District, we were particularly pleased with the partnership that occurred with the adjoining homeowner association leadership under the invitation of Commissioner Johnson which led to an improved Overlay District Plan.



# PROJECTS ACCOMPLISHED DURING 2021

#### ARC scoping grant submitted to ARC in December

A Scoping/Feasibility study application was submitted to the Atlanta Regional Commission for funding consideration to evaluate potential roundabout options at the intersection of Cedar Grove, Thurman and Old McDonough.

The Scoping Study, if approved by the ARC, will examine the options for the development of a single lane roundabout; evaluating opportunities for applying a non-traditional roundabout that allows for all five approaches to have access to this new intersection.

The study will also examine how to resolve traffic congestion, delays and safety concerns directly attributable to a specific business that directly impacts operations of the intersection in question.

#### GTIB Constitution Freight Corridor Operational and Safety Project RFP

On September 28, DeKalb approved a \$3,614,622 SPLOST to be utilized on the "Constitution Corridor Operational & Safety" project as a local match for the State Road and Tollway Authority grant know as the Georgia Transportation Investment Bank (GTIB) which was awarded to the CID. DeKalb County is providing this grant for the right-of-way and construction phase for this existing project.

The funding program comes from a variety of key players to improve commercial and residential traffic flow in the Conley Area. Match funding is coming from GTIB in the amount of \$1 million and \$200,000 will come from the MSCID for the engineering and construction phases of the project.

As previously stated in a press release, "Once completed, the roundabout and the other associated improvements such as a signal at the Bailey Street intersection with Moreland Avenue and widening the road to 26 feet, will simultaneously increase the curb appeal by adding new landscaping, adding street lighting and sidewalks on the roadway at the roundabout intersection interchange," said executive director, Larry Kaiser. The new infrastructure will make an impact for years to come strengthening the Conley area. It will be equipped to handle cars and trucks for a safe and stable driving environment with large lanes and a sizable circular roadway.

The roundabout will connect Fleetwood Road, Fayetteville Road, Bailey Street, Woodstock Road and Constitution Way.



#### Hiring off duty DeKalb police officer

DeKalb Policeman Jason Daniels began patrolling for the Metro South CID in June.

This Brooklyn native with over 20 years of experience came to Atlanta in 2000 after serving with the New York City Police Department.

#### Continue to pickup debris and mow right-of-way's on CID roads

Russell Landscape has been providing cleanup services for the Metro South CID in picking up debris, mowing right of ways and on request assisting with tire removal. We now have a revised contract with a weekly plan for each area of the district rotating through each month. We think that you will notice great improvement in the months to come.

#### Norfolk Southern coordination to minimize blockage of Henrico Road at-grade crossing

Metro South CID Executive Director Kaiser reached out to Norfolk Southern regarding trains stopping at the railroad crossing on Henrico Road. This conversation led to new solutions.

The delays caused by congestion on Moreland Avenue and I-75 targeted blockage sequencing with lines entering terminals in Atlanta, at the same time the trains were also experiencing increased length which has happened over the past two years.

A study was done to analyze traffic counts during different times of day with two to three peak times identified. With the closure of the Cedar Grove Bridge, this blockage was further complicated by the fact there were no transportation routes other than through neighborhoods for trucks delivering and picking up products in the area.

Conversations led to direct railroad traffic to avoid stopping across on major roads during peak times and to seek scheduling changes with the objective to minimize disruption as much as practical going forward.

## COLLABORATION WITH GOVERNMENT LEADERS

It has been my pleasure to work with the Metro South CID (MSCID) for the past several years. I have seen the development of this CID from its infancy stages working with the previous and current leadership to drive change in the area. We will continue to work in a collaborative effort and form strong partnerships to yield results you can see!

The county has allocated \$6 million in SPLOST funding for road improvements. I have appropriated \$800,000 for the roundabout initiative. In addition, to the \$4 million for Cedar Grove Bridge repair, we have contributed \$80,000 to the Freight Study. We have been able to appropriate close to \$12 million over the last one and a half years for the area in the Metro South CID. We are now focused with you as our partners in the future helping you tap into the \$1.2 trillion Infrastructure bill signed by President Biden to include \$284 billion for transportation to rebuild our roads and bridges. We are changing the landscape for Southwest DeKalb in our residential and commercial areas.

Congratulations to the MSCID for the progress that has been made. I stand ready to partner with you for improvements as we continue to work together.

I want to thank the staff and board of the Metro South CID for their hard work and due diligence in improving the whole Southwest DeKalb area.
