TOPICS FROM 1/1/2025 TO 2/12/2025

- Meeting date for April remains the same as usual -2^{nd} Wed. Trip to Italy cancelled
- Fleetwood Cemetery cleanup and mowing costs; initial cleanup \$11,174.53 and \$3750 every 4 months. Will ask the county commissioners to take over this cemetery maintenance after 1 year. Working on the PR side of this event with a March 12, 2025 at 1 pm ground breaking low key event no speakers although possible newspaper or TV. Refer to C21 proposal below
- Concrete plant rezoning 2 parcels abutting Fayetteville and Fleetwood; sent consent form for owner to sign if rezoned. Planning Commission denied and required 2 month stay on decision. ED to email the BOC indicating our strong support for this rezoning from Light Industrial to Heavy Industrial
- Code Compliance update; Thurman/Old McDonough/Cedar Grove Road court appearance 11/19 Judge reduced fines and placed owner on probation to begin cleanup asap. Court appearance Feb 5 at 1:30 "Status Hearing" where code compliance will report condition of the site and judge to rule if there has been substantive cleanup. Feb 5th hearing outcome significantly different. Judge and solicitor was on the verge of releasing the owner without any fines since no citations were issued by the county between 11/19 and 2/5. CID expressed displease with decision judge delayed decision until March 5
- Illegal car auction business continue to operate at the end of Fleetwood spoke to owner DeKalb is assessing whether site is in compliance; no LDP, no trailer permit, no electrical permit, no business license.
- List of issues/priorities sent to CEO Johnson/Terry and Messiah (handout)
- Need to find a large parking lot to allow the CID to undertake a "truck rodeo" as a component of roundabout transportation planning grant need 2 acres. <u>Any help from the board would be much appreciated in terms of contacts for this stakeholder group</u>
- MSCID 10 year anniversary in 2016. Planning for a CID event. Thoughts?
- Moreland at Bailey signal permit approved by GDOT January 27, 2025
- Constitution Roundabout R/W acquisition on going, Schedule to be out-to-bid spring 2025
- Cedar Grove bridge opened late 2026 opening
- Security Patrol Services received WC from Community Patrol Services \$1M coverage for \$1765. Asked for costs for a \$3M General Liability coverage
- IIJA planning grant agreement signed with the Federal RR staff for the Constitution underpass project. DeKalb to advertise for transportation planning services in early 2025. Funding is authorized

- Asked C21 to re-activate web redesign. Finished 2/3 of the work in 2023 complete the revisions and have it go live in April
- Anticipate bi-monthly newsletters to commence in the spring
- CID Successes New Membership signup marketing tool CID accomplishments (handout)
- On-Call Accounting request for increase in contract amount see attached letter –
